Safety & Emergency Management Specialist

The Safety & Emergency Management Specialist position is a great opportunity for an individual, already in the industry, to gain additional knowledge, experience, and growth while supporting ERAC's emergency response and environmental emergency planning to assist our Plan members and stakeholders; all while advocating and promoting a safety culture. All training and mentorship will be offered through the support of ERAC's Safety & Emergency Management Director.

Reporting to the Safety & Emergency Management Director, the role of a Safety & Emergency Management Specialist will be to conduct and/or participate in several functions of the health and safety management system such as, facility inspections, worker observations, risk assessments, near miss and incident investigations, monitoring corrective actions and monthly safety meetings. In addition to health and safety management, this position will also take lead roles in developing Emergency Response Assistance Plans (ERAPs), Emergency Response Plans (ERPs), Environmental Emergency (E2) plans, policies, technical procedures and guidelines, audits, and for the development and execution of tabletop exercises, drills and full-scale exercises involving dangerous goods. All duties are to be carried out while keeping ERAC's mission, vision and values top of mind.

The successful candidate will possess:

- Certificate or higher in occupational health & safety
- 5 years' relevant experience in the hazardous materials emergency response industry and/or industrial or regulatory related positions
- Knowledge and experience in TDG-ERAP and ECCC-E2 regulations
- Knowledge and experience in HSE auditing, risk and hazard assessment
- Experience in oil, gas or chemical emergency preparedness and response planning
- Experience in strategic planning, prioritizing, supervision, detailed report writing and problem solving
